INFORMATION FOR CANDIDATES ADVERTISEMENT NO. 2 (1)

1. (i) Application must be submitted on the prescribed form together with the enclosed sheet of additional questions duly completed. Application forms must reach the Secretary, Haryana Public Service Commission, Bays No. 1-10, Block-B, Sector-4, Panchkula on or before the close of office working hours on last date for receipt of application forms failing which these shall be rejected. Non-furnishing of documents in support of qualifications/experience or submission of incomplete application form shall render the candidate ineligible.
(ii) A passport size recent photograph of the candidate, duly signed on the front by the candidate should be pasted on the first page of the application.
2. (i) These posts are temporary but likely to be continued. The Haryana Govt. New pension scheme will be made applicable. The appointment can be terminated on one months notice on either side if work and conduct is not found satisfactory. The period of probation is two years.
(ii) The selected candidate must be prepared to join duty immediately after selection.
3. **Scale of Pay:** Rs.15600-39100+Rs.5400/- Grade Pay.
4. **Essential Qualifications:**
 - (i) A Post Graduate degree in Town Planning from a recognized University / Institution making the holder eligible for the associate membership of the Institute of Town Planning (India)

(ii) Knowledge of Hindi /Sanskrit upto Matric standard.

5. **Age:** - A candidate should not be less than 21 years and not more than 40 years as on 30.6.2011.

(a) Age relaxation upto 45 years is admissible to unmarried women candidates of Haryana only.

(b) Age relaxation upto 45 years is also admissible to women whose husbands have been ordered by Civil/Criminal courts to pay maintenance to them; women whose husbands have remarried, widows, women who are legally separated from their husband or have been divorced; women living separately from their husbands for more than two years because of desertion; wives of serving disabled military personnel and widows of those who were killed in action. Women living separately from their husbands due to desertion will be required to submit with her application, an affidavit to the effect that she has been deserted by her husband and has been living separately from him for more than two years and this affidavit should be countersigned by two responsible persons such as members of the Legislatures, Local Bodies including Panchayats and the Bar Association. Where however, a woman who has re-married she would not be eligible for the above concession in the matter of age.

6. The candidates serving under Union/State Govt. will not be entitled to any benefit of their past service except in the case of their initial appointment under the Haryana Govt. by direct recruitment.

7. **Duties:** To supervise the work of Town Planning Cell at Head Quarter, Chandigarh.

8. No other facility such as rent free quarters etc. is admissible.

Note: (i) The eligibility of candidates with regard to qualifications and experience etc. is to be determined on 30.6.2011.

(ii) Incomplete Application Form i.e. without proof of age and minimum required qualifications will be straightway rejected without entering into any correspondence.
